### BUSINESS ARISING OUT OF THE MINUTES

3BA1

Work Plan Review Session

Pamela Alcorn said that a 2009 work planning session had not yet been held due to the unavailability of a facilitator although that an orientation session for new members was held instead. She distributed the CSAC Activity and Progress Report May 2009 to the Committee that, she said, provides detailed accounting status of action items from 2008's Work Plan.

### **DELEGATIONS**

4D1

Chuck McCandless, Outreach Worker representing the Canadian Mental Health Association, provided a presentation on homelessness and panhandling.

Chuck McCandless said that because there are so few people panhandling in Duncan it is not, in his view, a particularly large problem.

Mr. McCandless said that homeless people's behavior may be uncomfortable for some although, in his experience, these people are often the victims of violence and crime. Many homeless people have problems with drug and alcohol abuse and there are no beds in Cowichan to support their recovery, noted Mr. McCandless.

Mr. McCandless said that the new Warm Land House, which is currently under construction, will have 24 bachelor suites for transitional housing; however it will not have supportive housing for these people to transition into.

9:15 a.m.

Councillor John Koury joined the meeting at 9:15 a.m.

With regards to people panhandling on the Highway medians, Mr. McCandless said that he sees this as a safety issue for them. He noted that they earn \$80 to \$90 per day.

The Committee discussed: addictions as a progressive illness; the distinction between homeless and at risk of being homeless; the challenges for First Nations people and their place of residency (on or off reserve); and challenges facing seniors.

Pamela Alcorn distributed copies of research specific to the issues of homelessness that she had obtained during a workshop through the University of Victoria's Office for Community Based Research.

## Work Plan item #1: Continue to Review Community Safety Action Plan

In 2006 CSAC developed a draft Community Health and Safety framework entitled "Community Safety Action plan." This document provides an overall Strategic Plan to address safety within the Cowichan Valley region. Four building blocks provide the structure of the Plan: Policy and Guidance, Safe and Accessible Design, Building Strong Neighborhoods and Coordinated Action. The Plan provides the framework for the CSAC Work Plan each year.

# Work Plan item #2: Implementation of the Cowichan Region Safety Lens

The Community Safety Lens is a planning and development tool. As a framework document it considers safety, ensures adequate consultation and informs a range of procedures. Specifically, the lens provides planners, elected officials and developers with a tool to assess safety for proposed developments and planning in the Cowichan region.

Safer Futures has begun working with Planners within the CVRD to determine how the Safety Lens can be incorporated into development and planning processes.

# Work Plan item #3: "Barefoot in the Park" Cowichan Region Safe Needle Disposal Initiative

The Safe Needle Initiative is in its finalization stages with the final draft of the toolkit to be placed in the format of the Victoria model, the confirmation of disposal sites being coordinated, and printing, launch and distribution plans set for late October 2009.

# Work Plan Item #4: Review of Community Safety; Issues on the Table, Issues arising

CSAC continues to bring to the table discussions related to a number of issues in the Cowichan region. The Committee brings a community safety perspective that considers social issues as root causes of crime. In providing a safety perspective, the approach and solutions recommended by the Committee take into account the lived experience of citizens, including marginalized voices into the dialogue. The issues reviewed at CSAC in the last two years have been homelessness, panhandling, graffiti, parole community release, youth violence, racism and addictions.

**Purpose:** For information purposes only.

Financial Implications: See below.

<u>Interdepartmental/Agency Implications:</u> Primary funding for the initiative will be derived from CSAC funds committed up to two years ago (\$2000). Additional program costs (such as transportation, disposal etc.), will be covered by participating partners:

Vancouver Island Health Authority (VIHA) - will provide collection containers (to be confirmed) and disposal under existing contracts with Stericycle;

CVRD – will provide staff and storage space for collection and bulking of needles at regional recycling depots, will also provide transport of bulked needles to hospital for disposal, can assist with printing and distribution of Safe Needle Disposal Toolkit;

Participating municipalities – public works crews already performing needle collection as needed could be incorporated into proposed regional collection/transport systems, municipalities (such as City of Duncan) may also be able to provide public disposal boxes in key areas.

Background: The Needle Safety Initiative in the region started with a workshop facilitated by Safer Futures in May 2007. A concern about found needles was raised by residents and brought forward by the Cairnsmore and James Alexander Working groups to Safer Futures. The workshop was very well attended and of the solutions identified, regional planning for needle disposal was included. The recommendations were brought to the CSAC Committee which formed a subcommittee to develop the initiative.

<u>Discussion:</u> CVRD Recycling and Waste Management staff have been collaborating with the Barefoot in the Park working group over the past several weeks in order to establish a collection

and transportation network for found needles. The objective for this collaboration has been two-fold: to work with municipalities to identify appropriate locations for found needle disposal boxes; and to establish a centralized transport/collection system at regional CVRD recycling drop-off depots.

Under the proposed system, found needles would be disposed of in public disposal boxes located within participating CVRD member municipalities. This public system would augment the occasional collection carried out, as needed, by municipal public works staff. Municipal staff would be responsible for emptying disposal boxes and transporting full containers to CVRD recycling depots, where needles would be bulked for transport. Members of the public (those with individual 'found' needles, as well as medical users who need to dispose of several needles) would also be able to drop off needles at CVRD recycling depots. CVRD staff would be responsible for transporting bulked needles to the hospital, where they would be collected for disposal under VIHA's existing contract with Stericycle. This public collection service could also be offered at CVRD recycling depots located in Meade Creek and Peerless Road, as well as the south-end depot proposed for construction in 2010. This service would be offered in addition to existing needle exchange programs offered by most pharmacies to their customers (which capture the bulk of medical users).

At this time, the City of Duncan is the only municipality that has confirmed participation in this program. Discussions with Brian Parnell (City of Duncan, Public Works), have indicated that four potential locations exist within the City for the siting of public disposal boxes: Duncan Train Station/Charles Hoey Park (outside), Centennial Park, McAdam Park, and Government Street 7-11. However, given potential neighbourhood sensitivities to the siting of disposal boxes, further discussions with local community groups may be warranted prior to confirming these locations. CVRD staff are also hoping to initiate discussions with the District of North Cowichan in order to establish the potential for locating additional disposal boxes within the municipality.

The possibility of siting public disposal boxes at CVRD Recreation Centres (Island Savings Centre, Kerry Park, Shawnigan Lake, and Lake Cowichan) has also been discussed. However, this option has been discounted for now due to the cost of tamper-proof disposal boxes and some staff concerns regarding their use. Maintenance staff at regional recreation centres already perform needle collection services as necessary, and these can easily be delivered to bulking centres at regional recycling depots.

At this time, it appears that the majority of costs associated with this program will be covered as 'soft costs' by participating partners; however, some of the \$2,000 CSAC funding may be needed to provide storage containers for needles. Depending on the level of funding provided by VIHA, CSAC may need to purchase replacements for small containers used by municipal staff doing 'front-line' collection. However, as these containers are already provided free-of-charge by VIHA (through the Margaret Moss centre), staff anticipate that VIHA will continue to provide this service. Also, depending on the level of funding committed by participating municipalities, some of the CSAC funding may also be required to purchase steel lock boxes for public disposal containers (see attached image). However, there is a strong possibility that these boxes can be constructed 'in-house' by various public works departments, thus significantly reducing their cost and increasing the likelihood that participating municipalities will be able to fund this portion of the program. The City of Duncan, for example, is able to produce these boxes in-house.
