

Cowichan Valley Regional Hospital District

The Cowichan Valley Regional Hospital District (CVRHD) provides capital funding to Island Health for the following facilities within its boundaries:

- Cowichan District Hospital
- Cairnsmore Place
- Ladysmith Community Health
- Chemainus Health Care Centre

Capital funding is cost-shared with the province on a 60/40 basis, with the CVRHDs portion being 40%.

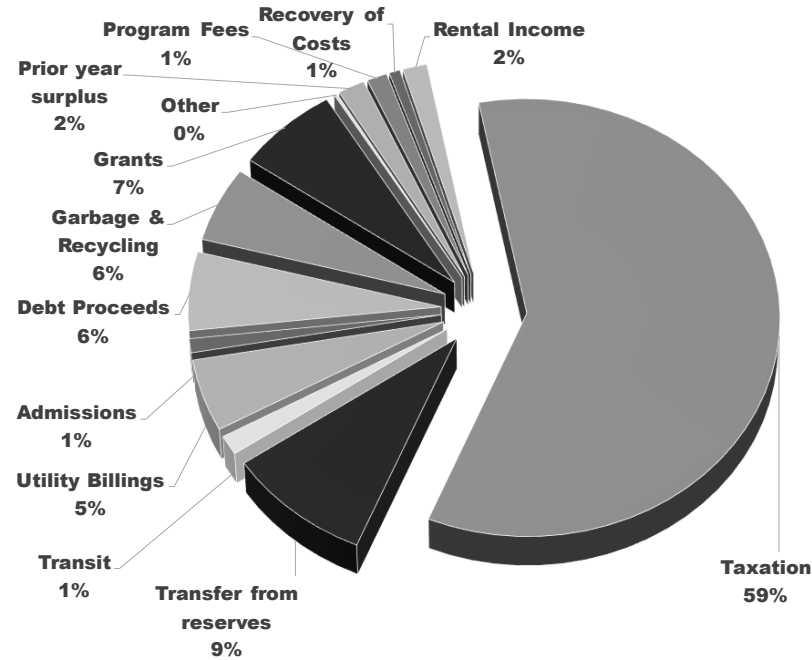
The CVRHDs 2019 Budget is \$27 million and the impact to a residential property is \$50.64 per \$100,000 of residential assessed property value.

Included in the 2019 Hospital Budget is \$5.2 million for the CVRHDs share of a new hospice facility.

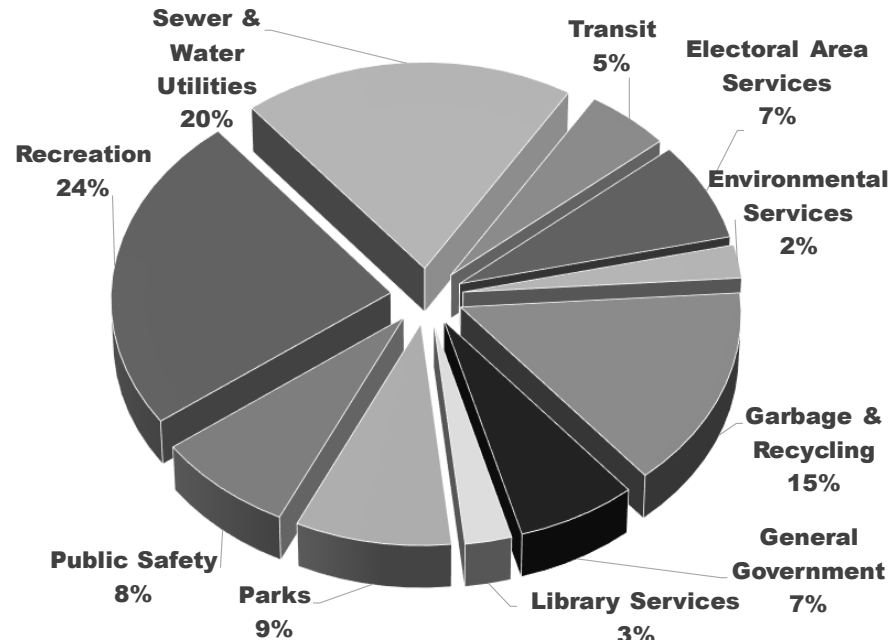
The Cowichan District Hospital is 50 years old and its replacement is Island Health's number one capital priority on Vancouver Island. Starting in 2010, the CVRHD has been putting funds aside to raise the Regional Hospital District's 40% share. At this point in time, \$46.5 million has been accumulated for the CDH replacement with another \$9.4 million to be added in 2019.

The proposed new hospital is in the planning phase. The Concept Plan has been completed, when it has been approved by the provincial government the next step is the Business Plan phase. Once the Business plan is approved by the Ministry of Health it is expected that the new hospital would be operational within five years. During 2016, the Regional Hospital District purchased land where the new hospital will be built. The site is on Bell McKinnon Road just south of Herd Road.

Financial Reporting Award

The CVRD received the Canadian Award for Financial Reporting for its 2016 and 2017 Annual Financial Reports. This award was established to encourage local governments to publish high-quality financial reports and to provide peer recognition and technical guidance for officials preparing these reports. Its attainment represents a significant accomplishment by a government and its management.

New Regional Services Established

Following public approval via a regional referenda in the 2018 Local Government Elections, the CVRD Board of Directors adopted Bylaw Nos. 4201 and 4202, establishing the Cowichan Housing Association Annual Financial Contribution Service and the Drinking Water & Watershed Protection Service, respectively.

The Cowichan Housing Association Annual Financial Contribution Service will fund costs associated with getting new housing projects underway that will help address the mounting crisis we are experiencing across the Cowichan region. The majority of funds requisitioned through this service will be committed to a housing trust fund that will be used to leverage other sources of government funding and ultimately be directly committed to brick and mortar projects.

The Drinking Water & Watershed Protection Service will enable the CVRD to implement programs and strategies for specific watersheds across the region, which will inform land use and infrastructure planning and result in better long term decision making. The majority of funds requisitioned through this service will be dedicated to developing and implementing these strategies, including watershed monitoring and data gathering, while also working with other levels of government and stewardship groups to meet service objectives.
