BYLAW No. 4228

A Bylaw to Establish the Question to be Used for the Cowichan Housing Association Annual Financial Contribution Service Referendum

WHEREAS the Board of Directors of the Cowichan Valley Regional District wishes to establish an Annual Financial Contribution Service for the purpose of assisting the Cowichan Housing Association with costs associated with providing programs and services related to affordable housing and homelessness prevention in the Cowichan Valley;

AND WHEREAS the participants in the proposed service would consist of the City of Duncan; the Municipality of North Cowichan; the Town of Ladysmith; the Town of Lake Cowichan and all Electoral Areas: A - Mill Bay/Malahat; B - Shawnigan Lake; C - Cobble Hill; D - Cowichan Bay; E - Cowichan Station/Sahtlam/Glenora; F - Cowichan Lake South/Skutz Falls; G - Saltair/Gulf Islands; H - North Oyster/Diamond; and I - Youbou/Meade Creek.

AND WHEREAS under Section 179 of the *Local Government Act*, the Board must, by bylaw, establish the question to be used if voting is conducted by more than one local government;

NOW THEREFORE the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. **CITATION**

This bylaw may be cited for all purposes as "CVRD Bylaw No. 4228 – Cowichan Housing Association Annual Financial Contribution Service Referendum Question Bylaw, 2018".

2. **ESTABLISHMENT OF QUESTION**

The following question shall be submitted to the electors of the City of Duncan; the Municipality of North Cowichan; the Town of Ladysmith; the Town of Lake Cowichan and all Electoral Areas: A - Mill Bay/Malahat; B - Shawnigan Lake; C - Cobble Hill; D - Cowichan Bay; E - Cowichan Station/Sahtlam/Glenora; F - Cowichan Lake South/Skutz Falls; G - Saltair/Gulf Islands; H - North Oyster/Diamond; and I - Youbou/Meade Creek:

"Are you in favour of the Cowichan Valley Regional District adopting "CVRD Bylaw No. 4201 - Cowichan Housing Association Annual Financial Contribution Service Establishment Bylaw, 2018" to provide regional programs and services related to affordable housing and homelessness prevention?"
